Advocacy leads to HB40 passage

January: IL HFS Notice

Addresses how to bill for Hyde cases, using paper Form 2390

November: IL HFS Provider Notice

Raises reimbursement rates; removes Form 2390; requires electronic billing. All claims for abortion billed directly to state (no MCOs)

December: Reimbursement rates raised

59840- Surgical, Induced, D & C	\$660.00
59841- Surgical, Induced, D & E	\$1,600.00

June: Dobbs vs Jackson

May: IL HFS Provider Notice

Affirms that Illinois state law guarantees a right to reproductive healthcare, including abortion and maternity care.

COVID-19 pandemic launches widespread use of telemedicine, including for abortion care

January: IL DHS Expands Provider Types

Any provider furnishing health care under Medicaid can be considered a qualified presumptive legitimacy provider

September: IL HFS Provider Notice

Allows providers to bill directly to Medicaid for abortions for dual Medicaid/Medicare enrollees. Rates increase:

59840- Surgical, Induced, D & C	\$792.00
59841- Surgical, Induced, D & E	\$1,920.00

September: Public Act 100-0538

Requires IL Medicaid to cover abortion care without co-pays

Jan 1 - Medicaid coverage starts; external funders support providers in coverage for patients with Medicaid while getting certified.
